

## Event Photography Terms & Conditions

### 1. Booking & Deposit

- A booking fee of £75 is required to secure the event photography services and reserve the date. This deposit is non-refundable under any circumstances, including cancellation by the client, unless otherwise agreed in writing.
- The booking is considered confirmed only upon receipt of the deposit and written or emailed confirmation from Mark Hurst Photo.

### 2. Payment

- The remaining balance for services is payable on or before the date of the event. No images will be released until full payment has been received.
- Payment details will be provided upon booking confirmation.

### 3. Service Delivery

- Images will be delivered within 7 days as standard. If you require a faster delivery timeframe, this can be arranged for an additional fee - please ask for details. These delivery terms are the default for all bookings.
- Delivery will be via secure online gallery or digital transfer.
- You - as the event organiser and primary contact - will have full access to all images.

### 4. Image Usage & Licensing

- The business/organiser is granted a non-exclusive license to use the delivered images for digital use only, such as on the business's website and social media accounts, as agreed. Any use of the images in printed materials or for broader marketing purposes - such as printed brochures, flyers, signage, or advertisements - requires prior written permission from Mark Hurst Photo.
- Where images are distributed to event attendees, attendees are permitted to use the images for personal social media use only; any commercial or promotional usage by attendees must be subject to prior written consent from Mark Hurst Photo.
- The photographer retains full copyright and intellectual property rights, except where explicitly transferred or licensed in writing.

## 5. Cancellation & Refund Policy

- The deposit is non-refundable. If the event is rescheduled with more than 48 hours' notice, the deposit may be transferred to a new date, subject to photographer availability.
- Cancellation by the client with less than 48 hours' notice will result in forfeiture of the deposit, and additional charges may apply.

## 6. Liability & Force Majeure

- Mark Hurst Photo is not liable for failure to provide services in case of circumstances beyond reasonable control, including but not limited to illness, equipment failure, accidents, or force majeure events (fire, flood, strike, adverse weather).
- In the case that Mark Hurst Photo is unable to attend the event, every effort will be made to find a suitable replacement. If no replacement is available, all payments (excluding the non-refundable deposit) will be fully refunded.

## 7. Artistic License

- The photographer will use their professional judgment regarding style, editing, and selection of images delivered. All images are edited at Mark Hurst Photo's discretion, and delivered images may not include every photograph taken during the event.

## 8. Data Protection & Confidentiality

- All personal information exchanged between the client and photographer will be processed in accordance with the UK Data Protection Act and not disclosed to third parties except as required by law or for contractual fulfillment.

## 9. Modification & Agreement

- These terms constitute the entire agreement between Mark Hurst Photo and the client. Any changes or additional terms must be agreed in writing by both parties.
- By booking, the client acknowledges and accepts these terms and conditions.

We reserve the right to cancel or terminate your booking at any time if you breach any of the terms and conditions outlined in this agreement.
